## 2. SAT & ACT ASSESSMENT & PRACTICE TESTS

For high school students interested in ME's private or group SAT or ACT classes, ME offers one free assessment test, which is necessary for student placement and to gauge student progress. If you are not sure whether you should prepare for the SAT or the ACT, we are happy to offer two free assessment tests (one of each), after which we will generate a comparison chart to help determine which test seems more suitable. For new enrollees, any free assessment test must take place at the time of enrollment, which is when we need test results for student placement. Tests taken at a later time or any additional tests constitute "practice" tests for which ME charges \$60 (or \$120 for test scores together with an evaluation report and test prep recommendations) each.

## 3. TEST LENGTH AND SCHEDULING

**SAT** tests last approximately four hours and fifteen minutes (4'15") and **ACT** tests last approximately four (4) hours. Tests are administered at Mercer Education (ME) on Saturdays and Sundays at 9am and 1pm and include some time to get students settled and review testing protocol. Because of the length of these tests, students generally cannot take them on weekdays, though ME does administer practice tests by appointment. Indicate scheduling/test preferences here:

Important Details: 1) Evaluation reports w/scores will be emailed to you within approximately 10 days of the test date. 2) For practice tests, payment (check or cash) must accompany this registration form to reserve a spot. Please mail or deliver in advance to Mercer Education at the address listed above. 3) If you plan to show up on a "walk-in" basis, please be aware that there may not be space for you and that ME does not necessarily administer practice SAT tests every Saturday and Sunday. 4) For the sake of all those attending the test and administering the test, ME's practice SAT's are administered on time as scheduled, and we recommend that students plan accordingly and arrive a few minutes prior to the test's scheduled start time. 5) Students should bring a calculator, several pencils, and a snack if desired. 6) Students requiring special accommodations should inform ME in advance to confirm whether those will be available.

## 4. STUDENT AGREEMENT

To come prepared and to commit to do the best you can on your own merit, please read the following statement and sign below: "I understand practice SAT and ACT tests last about 4 hours. As under real test conditions, I will show up early and bring a calculator and several sharpened pencils.
