Tuition and Registration Details - Sign up early to reserve a space and avoid late fees.

To reserve a space in Mercer Education's summer camps, each student must submit a completed, signed application together with a *prepayment equal to half the total tuition* owed. The deadline for normal enrollment is June 1 for both sessions. Tuition costs (not including books and materials) for ME's Summer Camps are:

In addition to this *prepayment*, new students must each pay a 40.00 one-time non-refundable *registration fee* for scheduling classes and establishing an account. Students whose applications are received after ME's June 1 registration deadline must pay an additional late sign-up fee of \$75.00. Each camp requires an *assessment* which must be completed at least one week prior to the start of the camp. Any *remaining unpaid balance of the tuition* is also due one week prior to the start of the camps. Please see our *Summer Camp Policies* for details.

No Guarantee Policy - Students are admitted to ME's summer camp programs on a "first-come, first-serve" basis, and spaces are limited. Scheduling priority is based on the date on which applications are received, and generally those who apply early will not have trouble securing a space. However, ME cannot guarantee a space for everyone who applies. See ME's *Summer Camp Policies* and immediately below for details.

Scheduling: Advanced SAT Verbal Camp and Advanced SAT Math Camp - If you are applying for one of these afternoon camps, clearly indicate your first-choice scheduling preference (either M/Th OR Tu/F) on page 1 of this application. However, because many students apply last minute, finalizing schedules often occurs just days before camps begin, and sometimes enrollment may not be possible if students' preferred times for attending camp are unavailable. To avoid any misunderstanding, please check the appropriate box below to indicate you understand and agree to this policy and how ME should handle contingencies:

Private & Group Classes - In addition to the intensive summer camps listed herein, Mercer Education offers private and small-group classes throughout the year. Registration deadline for summer classes is June 1. For non-camp programs, use the "Summer Classes Application," not this one. Applications received after June 1 will incur a late sign-up fee of \$75. Applications and information are available at *www.MercerEducation.com* or directly at ME. Please contact us for more info.

Books and Materials - The cost of all textbooks used in the camps is not included in the tuition costs listed above and will be included on the first invoice. Students may not attend classes until the full camp tuition, registration and/or late fees, and charges for textbooks and materials have been paid in full. Late payments will incur a late fee charge equal to 5% of the entire month-long camp tuition. For ME invoices for other charges (e.g. other miscellaneous book purchases), payment is due upon receipt of invoice, and a late fee of \$5.00 will be added for every seven (7) days payment is not received after the invoice date.

Other Information about ME School Policies - All summer camps at ME will be charged according to our listed rates. Any other arrangements must be made in writing with Eric Cohen (ME's President) personally, and only Eric Cohen is authorized to enter into any agreement on behalf of Mercer Education.
